I have not sent you a series of threatening responses. It really bothers me that you have taken it that way. If you believe you have been threatened then I'm sorry but I understand exactly how you feel. What I don't understand is how you could not see where I am coming from or how being attacked and threatened by Tyra would make me anyone nervous and how her actions would elicit the response it has. She has explicitly threatened me with undisclosed evidence, with my mail, with Dan, with law school, with the phone and other things. If the goal is not to ruin, discredit and fight with me then why doesn't she just stop? There is a way that you conduct yourself if you don't want a fight and that isn't how she is acting. I've tried to let you know this isn't where I want to take this by making a series of good faith gestures apparently she has interpreted that as weakness or an unwillingness to defend myself.

Being called names is one thing. Being leveraged with a mountain of hidden evidence is another. She is not giving me any signs other than aggression and hostility. We only need a few things to proceed peaceably here. What I want is simply a letter from the Board and you acknowledging that I have conducted myself with integrity, been a good employee, and have not done anything untoward, inappropriate or unethical. I think allowing me to maintain my integrity serves everyone's interest more than manufacturing conflict from whole cloth and then menacing me with a list of how I can be damaged or discredited. If you can't see how the threats and leveraging from your end have brought us to where we are I'm sorry. I'm weary of all this but her tone and rhetoric would make anyone nervous and we all have too much at stake to ignore her. If you can negotiate providing me with a letter then I'm not compelled formally refute Tyra's accusations in front of the board. !

If you can't do that I'll make my case to refute what ever it is she is saying about the BSO thing, any alleged thefts and all of her other allegations.

I don't think it would be a good thing for you to address anything to my mother. She and Esther know about Tyra's threats regarding law school and if I followed either of their advice we would be in a very different place. My mom is very upset about all of this and has enough other things to deal with. Esther has repeatedly asked me to let her contact you but I can't observe the negative effect that Tyra's involvement has had and then conclude that injecting anyone else would make matters better. Let me know your thoughts.
