Clinton Slate



Dear Mr. Slate:

I spoke with you several months ago about your son Greg Slate, a former member of my organization - The Police Complaint Center. During our call I informed you that Greg had been causing problems in my organization. Since that time, Greg has been terminated as a volunteer from the Police Complaint Center. I will not go into all the reasons Greg was terminated except to say that the matters were serious and the list of his transgressions are long.

After Greg's termination, he was advised not to contact me. He was also asked to return all company equipment and PCC mail in his possession. Greg refused to return the mail and the equipment he was issued. Ultimately, his fax services, company cards, telephone and e-mail services were turned off. He was told all his duties on behalf of the Police Complaint Center ended.

Approximately 2 weeks ago, Greg showed up at our company mailbox. This visit was more than three months after he was separated from the organization. Greg told the mail clerk, Hector, that I was out of the country and he was responsible for retrieving our mail. This was a lie and a violation of the terms stated at the time of his termination. In response to Greg's attempt to collect our mail, we have posted a notice on our website alerting clients and customers that Greg Slate no longer works for the Police Complaint Center. That notice shall remain on our website indefinitely.

I would like to follow up with you on our conversation from several months ago. However, before going further I should inform you that Greg

communicated to me that you did not want to be contacted. Though I assume this is just another lie, you may contact me by e-mail ([REDACTED]) and inform me of your true sentiments. If you do not desire additional communication you will not receive any further correspondence from me or anyone within my organization. As this may be the last time we communicate, I want to make you aware of a few things I have learned about Greg.

It was very difficult terminating Greg from my organization. When Greg started at the PCC he was only 17 years old. With his mother's consent on a signed waiver, I personally groomed him as an investigator teaching him everything I knew about undercover work and hidden camera investigations. Greg was appointed to the position of Director. Not only did I trust Greg as a professional colleague but I considered him a friend. My trust and confidence in Greg were misplaced. I have learned over several weeks that Greg has been stealing money from clients, abusing my reputation and recklessly using my organization for attacks on friends and foes alike.

As his dad, I know that you care about him despite what has been a rocky relationship. When your name came up in our conversations he spoke with the greatest derision about you. I know now that much of what Greg told me was untrue. Yet, I am aware of several attacks on you and your family members. I know that Greg repeatedly contacted child protective services accusing your wife of a sexual liaison with his half-brother. I know that Greg filed a false report with the West Virginia bar association against your attorney. I know that Greg contacted your attorney at her residence while she was pregnant and much, much, more.

I have asked Greg to leave me alone and never contact me again. Apparently, he is not listening to me. I do not want to hurt Greg or anyone in his family. I have donated several computers, articles of clothing and even vehicles to Greg and his mom for their personal use. I hold nothing against Theresa, Jonathan or Tyler. However, Mr. Slate I am not prone to bluffing. When I tell you that I have enough information to put Greg in jail for at least 30 years, I am serious. This will not end up as one of Greg's games such as those played with your sister at her job or with your attorney and the West Virginia Bar Association where I know Greg made false reports.

For the record, Greg has also filed false reports with child protective services

against at least five other individuals in four states. I am aware of at least eight felonies he has committed or been party to including; theft of public records, burglary, arson and mail fraud. These crimes do not include his allegation to WV Child Protective services that your wife had sex with his half-brother. I have dates, times and witnesses to these events. I can demonstrate that Greg did not complete his college course work within UMD requirements. I know for a fact that he plagiarized and falsely represented himself as a professor online to obtain answers for exams, papers and quizzes.

Greg is in over his head. If I am bothered again by Greg I do not intend to write more letters and e-mails. My first call will be to Prince George's County police department. Greg and his girlfriend Emily recently had a young man arrested on drug charges solely because they didn't like the owner of his house. The young man had the misfortune of renting a room in a building shared by Greg's girlfriend Emily. When the apartment manager declined to give Emily a refund of her deposit, Greg filed several false documents against the manager with the state realtor board. When that effort did not produce the results he wanted he decided to take the entire building down by tipping off police to drug use and sales in the building by the young man who was also a college student. I believe that the information supplied to the Prince George's County police department was false. Moreover, a search warrant obtained by PG police is based on very questionable information supplied by Greg and Emily his girlfriend.

My second call will be to the arson squad in Charlotte, North Carolina. Greg was involved in an insurance fire that the police are currently investigating.

The last call I make will be to the University of Maryland's registrar's office. I have conclusive proof that will disqualify Greg for his bachelor's of science degree.

Rest assured Mr. Slate these are not measures I look forward to taking. However, if Greg thinks that this is just another one of his high school hi-jinks where everyone laughs it off later he is mistaken.

Recently Greg purchased my name, Diop Kamau through a proxy/shell web company. Though he had hidden his contact information his motive is nonetheless evident. In the past, Greg has purchased the names of people he

dislikes so that he may post harmful information about them on the Internet anonymously. Because I suspected this possibility, Greg signed a comprehensive confidentiality agreement before leaving the Police Complaint Center. In the event that any information about me or my organization is posted to this or any other website I intend to sue Greg in the first legally accessible jurisdiction. Please do what you can to rein him in for his own good. If your intervention does not work I will do what is necessary to permanently shut him down.
