The event occurred on 9/1/10 at approximately 1800 at 1708 Kilbourne Place NW in Washington DC.

I, Officer T. Sibert, operating as a 10-99 unit under call sign 3011 driving scout car "3011" in full class B uniform responded to the above listed address for a "suspicious person" call. Upon my arrival I was met by W-1 who stated that D-1 (later identified as Greg Miller) had fled the scene. Officer N. Brown canvassed with negative results.

Thereafter, W-1 reports that D-1 was standing in front of W-1's girlfriend's home at listed location when W-1 arrived to the location at approximately 1800 hours. W-1 further reports that he began to walk up the stairs located in front of the listed location at which time D-1 walked up behind W-1. W-1 states that when he turned around D-1 grabbed W-1 with both hands by W-1's shirt and stated "Drop that fucking lawsuit against ABC"! W-1 reports that D-1 then pushed him and fled the scene in an unknown direction.

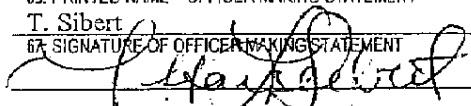
D-1 returned to the scene while I was still investigating. At which time W-1 yelled, "That's him!" by pointing at D-1 and ran away from D-1.

D-1 was then placed under arrest for Simple Assault and transported to the Third District for processing.
